- d) To promote, advance and encourage and/or aid in helping, promoting, advancing and encouraging primary, secondary and higher education including technical and medical education and also physical training, and other useful arts, crafts among the public including the establishment and maintenance of Shilpa-Shikshalayas, Kala kendras and other welfare centres for them.
- e) To foster and encourage education and training in handicrafts, fine arts, among women folk in general and establish and found institutions imparting such education and to establish, maintain, support or help for monetary gifts or otherwise, centres and institutions for women and children and to provide social welfare works for women and children.





uu) To publish books, periodicals, journals, magazines, etc. produce documentary and other educational films for promoting education to the deserving irrespective of the caste.

- vv)To undertake propaganda, training and education of the masses either of its own or in co-operation with similar Agencies working for the cause of all round development of the Society.
- ww) To bring, publish, sell and distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- xx)To acquire and maintain the movables and immovable properties for achieving and said objects.
- yy)Generally, to do all such other things as are deemed incidental or conducive to the attainment of all or any of the aforesaid objects.
- 5. If any one or more of the objects specified in clause (3) of these presents are held not to be objects of the trust, the trustees shall not carry out such object or objects as if the same are not incorporated in these resent but the validity of the trust created by these presents as a trust for purposes shall not be affected in any manner.
- The financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be liberty to change the same from time to time if they so deem it fit and proper. The first financial year of the trust shall close on 31st March 2019.

### CORPUS (OR) TRUST PROPERTY (OR) TRUST ESTATE:

The Trust property or the corpus shall consist of the above said sum of Rs.10008/- (Rupees Ten thousand eight only) now granted and dedicated by the Author.

However, the Board of trustees may accept any donation or contribution in cash or in kind from any person, firm, company, corporation, associations, institution or trust (including the Author of Trust or the trustees or any of them) for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust. The trustees may also take over the management of any other charitable or public institutions on such terms as they think fit and may manage such institutions.

8. SHASTRY are permanent trustees. The First trustee is the Managing Trustee and the Second Trustee is the Secretary of the Trust. The Permanent trustees will be at liberty to appoint /co-opt additional Trustee/s if he so desires for the better administration of the Trust.

- (iii) Office bearers of the Trust who are elected as such by and amongst the Trustees.
- 12. Without affecting the generality of powers and functions of the trustees to manage an administer the trust, the Board of Trustees shall have the following functions:-
- (i) To borrow if needed be against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees to execute such documents, deeds, papers, etc. as may be necessary in connection therewith.
- (ii) To arrange for and/or authorize the signing or execution of any agreement, contract instrument, document of any other paper or writing required to be signed or executed on behalf of the trustees by any two of the trustees to be nominated in this behalf by the Board of Trustees and to make the same effective and binding as if the said agreement, contract and binding as if the

- (v) To spend any portion of the corpus or the income of the trust fund for purchasing any land and or constructing any building or buildings for and in the name of the trust for the purpose of carrying out promoting and/or executing any or all of the objects of the trust.
- (vi) To cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of trust properties of in relation to the carrying out of the objects and purpose of the trust as well as of all the assets, credits and effects of the trust properties.
- (vii) To invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties, or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to in sub-sec. (3) of sec.
- (viii) If the income from the trust property in a particular year is not fully utilised, the unexpended income subject to the applicable provisions of the Income-tax Act, 1961, shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the object of the trust.
- (ix)To sell such portion or portions of the movable or immovable properties forming part of the Trust Estate either by public auction or by private contract at such price or prices and in such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and to execute all conveyances or other assurances and to pass valid and effectual receipts and discharges for all manyeys received by them.

- (xiii) To appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, Gomastas or other employees for the purpose of management and supervision of the Trust Estate, for collection of rents, effects and profits, for keeping the accounts and records and for other purpose of the trust.

15. Any trustee may retire at any time without assigning any neason without being, responsible for any costs occasioned by such religement

16. The surviving or continuing trustees may notwithstanding any vacancy in their board act as trustees PROVIDED HOWEVER that if the number of \* trustees shall fall below two the minimum fixed by these presents, the \* trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum.

- 17. The Trustees shall not be entitled to any remuneration for discharging their duties as a Trustee. And they shall however be entitled to receive the expenses incurred by them from out of their pocket in the course of discharge their functions and duties in furtherance and achievement of the objects of the trust.
- 18. The trustees shall receive the honorarium or salary against his/her services or involvement in any of the project or program run by the Trust, which must be decided by the Board of Trustees and approved by the Chairman / Chairperson.

#### 19. Proceedings of the Board of Trustees:

- The Meeting of the Board of Trustees shall be held atleast once in 3months provided any number of to other meetings may be held as and when considered necessary.
- zz) The quorum for the meeting of the Board of trustees shall be two thirds of the board Within 30 minutes of time prescribed for the meeting of the Board of Trustees, if no quorum is formed the meeting shall stand adjourned to any other day to discuss the same agenda and at such adjourned meeting if no quorum is formed the members who are present may transact the business for which the meeting is called for. However in such adjourned meeting no new subject shall be considered.
- aaa) A clear notice of 3 days shall be given under certificate of posting for convening the meeting of the board of Trustees unless it is an emergent meeting Notice of the meeting of the trustees and all communications may be sent to the trustees at their addresses registered for the time being in the records of the trust.
- bbb) The minutes of the proceedings of every meeting of the trustees shall be entered in a book to be kept for that purposes and signed by the President of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

The Board of Trustees for the time being shall elect from amongs them one President and he shall hold office for years, unless he resigns of refuses to act as President or otherwise ceases to be trustee.

- 20. All proceedings and questions and matters arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes the President shall have a second or casting vote PROVIDED HOWEVER that notwithstanding anything herein stated no question dealing with the disposal of the corpus of any of the trust properties and/or investment out of the trust corpus shall be decided except with the consent of the President of the trust.
- 21. A resolution in writing circulated amongst all the trustees and signed by a majority of the Board of Trustees shall be as valid and effectual as if it had been passed at a meeting of the trustees duly called and convened.
- All meetings of the trust shall be held at such place and at such time as the President of the trust shall decide from time to time.
- 23. A trustee who is unable to be present at a meeting of the trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.

#### 24. POWERS, FUNCTIONS & DUTIES OF THE BOARD OF TRUSTEES

- (i) The Board of Trustees may, by its resolutions enlarge, abridge, or alter the powers, rights, privileges, duties, functions and obligations or any of the office bearers by majority of the total number of Board of Trustees.

- (viii) At present no property is involved in this deed of Trust.
- (ix) The office bearers of the Trust shall cause the Accounts to be maintained under the direct control of the Treasurer or President or Secretary and the Banking Accounts shall be operated jointly by the Treasurer and secretary or President.
- (x) The Board of Trustees are empowered to pass the statement of accounts every year and financial year shall commence on the first of April every year and end on the 31st March of the succeeding year. The official year may be varied at the discretion of the Board of Trustees in conformity with provisions of the Income tax, act 1961.

#### 25. OFFICE BEARERS OF THE TRUST:

## 26. The obligations of the office bearers as follows:

- (i) MANAGING TRUSTEE/PRESIDENT: The Author of the Trust shall be the President and shall preside over all the meetings of the Board of Trustees and shall be entitled to have casting vote if there is a tie or equal division in opinion in the voting on any subject.

- (v) TREASURER: The Author of Trust is the Treasurer shall maintain or cause to be maintained the accounts and be accountable for all receipts and expenses of the Trust and he shall be exercising his/her power in conformity with the decisions of the Board of Trustees in all financial matters; decisions of the Board of Trustees in all financial matters; the by-laws.

#### 27. REMOVAL OF THE OFFICE BEARERS:

Any office bearer may be removed with or without assigning any reason whatsoever by ¾th majority of the total members of the Board of Trustees notwithstanding the period for which he was elected. The office bearers shall also exercise all such powers, perform such duties respectively as may be decided ad delegated by the Board of Trustees in furtherance of the object of the trust.



## 28. RETIREMENT, REMOVAL OF TRUSTEE:

No person being --

- (i) an undischarged insolvent; or
- (ii) convicted of an offence involving moral turpitudel; or
- (iii) of unsound mind; or
- (iv) a minor;

Shall be eligible to be a trustee.



- 29. The Board of Trustees may, by a unanimous vote of all the trustees for the time being except the trustee proposed to be removed, remove any trustee, permanent or otherwise, from office after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the trust estate or trust affairs and after arriving at a definite conclusion that for the reasons to be recorded in writing the continuance of the trustee proposed to be removed as trustee or these presents was desirable keeping to the objects of the trust in view and other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining his conduct and/or the charges leveled against him for his removal. And the decision of the Board of Trustees in this behalf shall and the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called in question anywhere.
- 30. The power to appoint new or additional trustees, but so as not to exceed the maximum number and to fill vacancies in the office of the trustees, shall vest in the continuing trustee or trustees.
- The Board of Trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.



- 34. No amendments to be Trust Deed / Bye Law / Rules and regulations shall be made which may prove to be repugnant to the provisions of section 2(15), 11, 12 and 13 and 80G of the I.T.Act, 1961 as amended from time to time. Further no amendment shall carried out without the prior approval of the Commissioner of Income-Tax.
- 35. In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees / Members of the Managing Committee/ Governing body but the same shall be transferred to another Trust whose objects are similar to those of the Trust and which enjoys recognition under s.80G of I.T Act,
- 36. The Trust formed shall be irrevocable. (only in respect of Trusts).
- The funds and the Trust shall be open to all irrespective of caste creed or religion.
- 38. The funds and the income of the Trust shall be solely utilized for the achievement, of its objects and no portion of its shall be utilized for payment to the Trustees by way of Profit, interest dividends etc.,
- 39. The Board of Trustees shall have all the powers to do any act, deed or thing in respect of which no specific provision act, deed or thing in respect of which no specific provision is made for under this deed which is found necessary for carrying out the purposes and objects of the Trust. At present no immovable property is involved in this Trust.

40. The power duties and functions of the Trustees and other not specified herein shall be governed by provisions of Indian Trust Act 1882 as may be applicable.
